To Disable Cookies on Chrome

1. Go to the **Chrome** menu icon and click '**Settings**'
2. Click "Show advanced **settings**" at the bottom.
3. In the "Privacy" section, click "Content **settings**" button.
4. In the "**Cookies**" section, Click "All **cookies** and site data"
5. To Delete all **cookies**, click "**Remove all**" button.

To Disable Cookies on Internet Explorer 11

1. Select the gear in the upper-right corner of the screen, then select "**Internet Options** ". ...
2. Click the "Privacy" tab.
3. Select the "Advanced" button.
4. Under "First-party **Cookies**" and "Third-party **Cookies** ", choose one of the following: ...
